1. CSDA LEGISLATIVE UPDATE - Dane Wadle'

CSDA Rep. Dane Wadle' gave an overview of proposed legislation that would affect CSD's. AB557 would allow districts to continue to use digital meeting platforms during a state of emergency. The current law allowing for digital meetings will expire at the end of the year. AB1637 did not pass. It would have required districts to have a .gov domain name to identify the district as a government agency.

There is a Ballot initiative that would restrict how districts set their fees/special taxes. The initiative states fees/taxes can only be based on the minimum amount necessary to provide the service(s). However, there is no definition of what that means. It would also raise the legal standard for Districts to defend themselves against letigation. The current standard is the preponderance of evidence. The initiative would raise the standard to clear and convincing evidence, which is a much higher standard. Any fee that was approved post January 1, 2020, would not be in compliance and would have to go back to the voters.

Dane also reported that CSDA is trying to get a definition of Special districts into federal law. This came into play during COVID. Special districts do not qualify for federal funding because there is currently no definition under federal law.

CSDA is also trying to get funding from the State for water infrastructure for firefighting.
